Collegio Nuovo – Sandra and Enea Mattei Foundation is a University College of Merit recognized and accredited by the Italian Ministry of University and Research. It is one of the 20 institutions affiliated with the **CCUM – Conference of University Colleges of Merit**, as well as a founding member and institutional partner of the IUSS – University School for Advanced Studies of Pavia.

It was founded in 1978 by entrepreneur Sandra Bruni Mattei to **promote and enhance the talent** of deserving female students, offering them a life and educational experience aimed at fostering their personal, social, and professional growth. The College hosts **112 female students** enrolled at the **University of Pavia** (and **50 recent graduates** in the Graduate Residence), providing them with privileged living and study conditions in a culturally rich, stimulating, and very comfortable environment. All places at Collegio Nuovo are assigned through a **public competition based on merit** and are **financially subsidized** according to family income.

Located within a 35,000 m² garden in the **heart of the scientific and biomedical campus of the University of Pavia**, and well connected by public transport to the city center, the College offers high-quality daily services and features efficient facilities for **study, sports, and leisure**.

It promotes a rich and innovative **cultural and educational program** (including a specific **tutoring** service for first-year students) that complements the university curriculum, supporting the development of personal and transversal skills required in the job market. It also boasts **numerous**

partnerships with prestigious academic and research institutions **worldwide**, which about 20% of the students benefit from each year.

Collegio Nuovo is a founding member and institutional partner of the **IUSS School for Advanced Studies** of Pavia, recognized by the Ministry of University and Research. The IUSS School (www.iusspavia.it) offers Ordinary Courses free of charge to its students — advanced, multidisciplinary programs that run alongside their chosen university degrees. Upon completion of a Master's degree, the IUSS School awards a legally recognized qualification equivalent to a **Second-Level University Master's Degree**, which is issued in addition to the **College Diploma**. The School also offers its students an **annual scholarship** (€ 5,000 for the academic year 2025–26).

With the goal of further promoting talent and merit and providing greater financial support to its students, **Collegio Nuovo has unified its admission process for candidates enrolling in the first year of Bachelor's or Single-Cycle Master's Degree programs with that of the IUSS School**. The admission tests and related results will therefore be the same, even for those applying only to Collegio Nuovo and not to IUSS. Once the ranking of the 30 winners of the joint competition with IUSS has been exhausted, the Administration Board of Collegio Nuovo will use the same ranking list to assign additional places to candidates next in line.

***Please note that Collegio Nuovo is a women's college. In the case of male students admitted through the joint Collegio Nuovo – IUSS competition, they will be accommodated in the adjacent Graduates' Residence, with access to all College services, including meals.**

AVAILABLE PLACES

22 places are available for students enrolling in the **first year** of Bachelor's or Single-Cycle Master's Degree programs at the University of Pavia (Pavia campus). If additional places become available, the Administration Board reserves the right to use the ranking lists from the joint Collegio Nuovo–IUSS competition, also taking into account the balance among academic disciplines.

All places are financially subsidized.

SPACES, SERVICES AND OPPORTUNITIES

The College offers accommodation in **single rooms** with **private bathrooms**, **air conditioning** and **free Wi-Fi**, weekly cleaning service, linen change, and utilities included. A 24/24 front desk and night security service is provided. Meals are **prepared in-house** under the College's direct management, with breakfast, lunch, and dinner served daily (7 days a week), except during summer closure and the Christmas and Easter holidays.





Students can choose from a wide range of **exclusive cultural and educational activities** which are reserved to them, including courses in **Career Management Skills, Languages, and Computer Science**, as well as University of Pavia-accredited courses and public events.

The College also provides **individual services in tutoring, coaching, and career guidance**.

Thanks to its many **international partnerships**, students of Collegio Nuovo can study anywhere in the world—from Japan to the United States—with financial support from the College, which offers **scholarships for study abroad**, including for independent projects.



ADMISSION REQUIREMENTS TO THE COMPETITION

In order to be admitted to the Collegio Nuovo - IUSS unified competition, applicants must:

- possess an **Italian High School diploma with a final mark of at least 80/100** (or an equivalent mark, if obtained abroad)
- have correctly completed the **application procedure for the IUSS call** for students from the University of Pavia within the prescribed deadline, which is available at www.iusspavia.it
- have correctly completed the **application procedure for the Collegio Nuovo call** within the prescribed deadline, which is available on the College's website: <https://colnuovo.unipv.it/>
- be **under 23 years of age** in 2025.

APPLICATION AND DOCUMENTS FOR ADMISSION TO THE COMPETITION PROCEDURE

Participation in the unified Collegio Nuovo - IUSS competition requires completion of **both of the following actions**:

- By **12 noon on Friday, August 29th, 2025**, submit online the application for admission to the **IUSS School for Advanced Studies of Pavia competition** through the procedure activated at <https://www.iusspavia.it/it>

- By **5 pm on Friday, August 29th, 2025**, submit online the application for admission to the **Collegio Nuovo competition** through the procedure activated at <https://colnuovo.unipv.it/en/ammissioni-in-collegio-e-sezione-laureati/>

Competitors will be asked to provide the following **documents in digital format**:

- self-certification regarding the possession of Higher Secondary Education Diploma** or equivalent foreign qualification, which entitle to university admission, with the indication of the score obtained (on a [form downloadable](#) from the College's website (Italian only) and in any case available when completing the online application)
- ISEE-University 2025 certificate** (only for those who intend to apply for financial concessions on the ordinary annual contribution). For applicants who have residence outside the household of origin or who are daughters of non-cohabiting parents, the attestation of both parents is required
- copy of **double-sided Identity Card** and **Social Security Number/Health Card**
- color passport picture**

After the online application process ends, the application form must be printed, signed (including by at least one parent of the applicant), and emailed to concorso.collegionuovo@unipv.it by the deadline.

The College has the right to verify the applicant's data and request additional documentation about

the family's financial situation.

The Collegio Nuovo Secretariat can help with the application process.

Please note that the application procedure for the competition requires submitting both IUSS and Collegio Nuovo applications, even for applicants interested in one of the positions offered by Collegio Nuovo and not those offered by the IUSS School for Advanced Studies of Pavia.

Inaccuracies or omissions in the declarations necessary for the issuance of the ISEE-University certificate may result in exclusion from the competition ranking or loss of the position awarded. The College reserves the right to verify with the relevant tax offices the regularity of the submitted application.

COMPETITION PROCEDURE

The competition consists of **two in-person written tests**, **two remote oral tests**, and an **online interview** with the Rector of Collegio Nuovo. The interview is a mutual presentation and is not scored.

a) Written tests

The written tests will be held **in person** on **Thursday, September 4th, 2025**. They will begin at 9:30 am at the Palazzo San Tommaso, located at Piazza del Lino n. 2. The entrance is on Via Siro Comi n. 55 in Pavia.

The total duration of the written tests may not exceed 6 hours, and papers may not be handed in before 2 hours. The tests are conducted anonymously and cover two subjects chosen by the candidates according to the following rules:

- the **first written test** must be **relevant to the scope (Class) of the degree course** to which the contestant intends to apply, according to the following scheme:
 - **Humanities Class** (Degree Courses in Humanities, Philosophy, Modern Languages and Cultures): *Italian, Latin, Greek, Philosophy, History*
 - **Social Sciences Class** (Degree Courses in Economics, Political Science, International Relations, Law, and the Interdepartmental Course in Communication, Innovation, and Multimedia): *Italian, Latin, Greek, Philosophy, and History*.
 - **Biomedical Sciences Class** (Degree Courses in Medicine and Surgery, Dentistry and Dental Prosthetics, Medicine & Surgery, Pharmacy and Industrial Pharmacy, Biological Sciences, Physical Sciences, Psychological Sciences and Techniques, Interdepartmental Courses in Bioengineering and Biotechnology): *Mathematics, Physics, Chemistry, Biology*
 - **Science and Technology Class** (Degree Courses in Engineering, Artificial Intelligence, Mathematical, Physical, Chemical and Natural Sciences): *Mathematics, Physics, Chemistry, Biology*
- the **second written test** will be on a subject **freely chosen** by the candidate, regardless of the Class and Field for which they are competing, as long as it is different from the one chosen for the first test.

Candidates must present themselves with **valid identification document**. No outside means of communication will be allowed during the conduct of the tests.

b) Oral tests

The oral tests will cover the **two subjects chosen for the written tests** and will consist of a discussion aimed at assessing the candidate's preparation.

The oral examinations will be held online, on the Teams platform, starting on **Friday, September 12th, 2025** according to a schedule that will be published by **Thursday, September 11th, 2025** on Collegio Nuovo and IUSS websites.

c) Interview with the Rector of the Collegio Nuovo

Self-presentation interviews will be held online starting **Monday, September 15th, 2025**, according to a schedule posted on the College's website and communicated via email to applicants. These interviews are for applicants interested in position at Collegio Nuovo who have passed the written tests. These interviews **are not scored**. Their sole purpose is to **facilitate an initial meeting** between the candidates and the Rector, who represents the College.

EVALUATION OF TESTS AND ELIGIBILITY FOR ACCESS TO RANKINGS

The Committee awards **each written test a maximum of 50 points** and **each oral test a maximum of 30 points**.

Those contestants who have obtained a score in the written tests of **not less than 70/100** will be admitted to the oral tests. The final ranking grade will be equal to the sum of the candidates' scores in the tests.

Candidates with an overall score of **at least 100/160** (for IUSS 110/160) will be included in the eligibility rankings for admission to the Collegio Nuovo.

ALLOCATION OF PLACES AND ACCEPTANCY

Places are allocated on the basis of the **following field rankings**:

- a) Human Sciences Class
- b) Social Sciences Class
- c) Science and Technology Sciences Class
- d) Biomedical Class

The results of the unified competition tests will be posted on Collegio Nuovo and IUSS websites by **September 19th, 2025**.

Competitors who are successful for a position at Collegio Nuovo will be **notified directly by the College by phone or email** no later than the following day and must provide statement of acceptance or waiver of the position **by email** by 10 am on Monday, September 22nd. Failure to provide notice by the deadline may be construed as a silent rejection. In case of any sliding of the rankings,

candidates following the first ones will be notified in the immediately following days.

Any allocation of additional places, which become available in addition to those in the competition, will also take into account the balance between the various disciplinary areas. In the event of a tie, priority shall be given to those in less favourable economic and financial conditions.

Admission to the College is scheduled to begin on September 28th, 2025, or in any case by the start date of university classes.

Students who attend the ***filter semester*** at the University of Pavia's Faculty of Medicine will be accepted into the College for the semester to attend the University's program and reconfirmed upon admission to the University of Pavia. See the last paragraph of this Notice for more details.

Successful applicants must also present the following upon admission to the College:

- **a certificate from their family doctor** attesting to the absence of illnesses incompatible with community life
- **two passport photos**, signed on the back
- **a certificate of enrolment at the University of Pavia**
- **a CV**, if available.

CONDITIONS OF PLACES AND FINANCIAL AID

The Collegio Nuovo fosters talent and merit by granting **financial concessions to all winning students** on the annual contribution of € 12,500. This amount is already reduced by 25% from the actual costs of training, room and board for the students.

These economic benefits are granted as follows:

a) Collegio Nuovo students who win a IUSS place

All Collegio Nuovo students who win a place in the 2025-26 academic year, called by the IUSS, will receive a € 5,000 Study Award from the IUSS. This award will be paid each year for the entire period of study, unless the students forfeit their IUSS place. **Students with a University ISEE of less than € 30,000 must pay € 5,000 to the College as tuition for the 2025-26 academic year and subsequent years, provided the ISEE value remains under € 30,000.** On the other hand, **those with a university ISEE greater than € 30,000** will have their contribution established based on the [parametric table](#) of benefits available on the College's website, which will be divided into three instalments. Thus, the College guarantees **free enrolment** for those with an ISEE of less than **€ 30,000**, as the reduction in the annual tuition fee of € 7,500 is fully covered by the Collegio Nuovo.

b) Collegio Nuovo students who are not winners or not interested in an IUSS position

The Administration Board may grant financial concessions to Collegio Nuovo students who are not winners or are not interested in a position offered by IUSS. **These concessions may reduce the ordinary annual contribution of € 12,500 with a grant by up to € 8,000. These concessions are granted based on the University ISEE and any other supporting documentation.** See the [parametric table](#) of available facilities on the College's website for more information. The College also reserves the right to offer additional concessions to students from economically disadvantaged families. The annual contribution is spread over three instalments.

Two free places will be awarded by the Administration Board to contestants ranked among the top 22 in the competition ranking. These places are named after the Founder, Sandra Bruni Mattei, and can be confirmed in subsequent years.

One of these places will be awarded to the candidate with the highest score on the competition tests, regardless of family income. In case of a tie, it will be awarded to the candidate with the lowest ISEE. For the other free place, the ISEE indicator must not exceed € 30,000. Recipients of these places who win the Nuovo-IUSS competition will not be required to pay the IUSS prize.

The Alumnae Association of the College will award a **prize of € 1,000** to the first runner-up enrolled in a **course of study in the humanities** with an ISEE of less than € 40,000.

All eligible students must apply for the EDiSU Pavia scholarship (<https://www.edisu.pv.it>). If awarded an EDiSU grant, students assigned a free or subsidized seat must pay two-thirds of the grant to the College.

It should be noted that all concessions, including free places, are reserved for those who do not take advantage of financial benefits offered by other Entities, public or private. In case of obtaining scholarships/awards from other Entities, public or private, a percentage defined by the Administration Board is required to be paid. Grants are also subject to compliance with the College's Rules and Regulations and may be revoked by the Administration Board in case of non-compliance with the same.

The Collegio Nuovo is also among the Institutions affiliated with **INPS** (former INPDAP, iPOST and ENAM managements) where it is possible to use the residential hospitality grant offered (up to the Master's degree) by INPS to the winners of its specific call aimed at students who are children/superstitious/equiparate of Public Administration employees and pensioners.

[INPS UNIVERSITY COLLEGE COMPETITION 2025-26](#)

This grant, which cannot be combined with any of the benefits offered by the College, entails a significant reduction (even total) of the ordinary annual contribution required by the College. All winners of the INPS announcement who are also winners of the competition for positions at the Collegio Nuovo will be eligible for admission to the College. **Application deadline July 30th, 2025, 12 noon on the INPS website www.inps.it**

Thanks to an agreement with **ENPAM**, other financial benefits are offered up to the Master's degree for children of ENPAM members and students enrolled in the last two years of the Faculty of Medicine. For more information, visit www.enpam.it and the College's website.

PLACE CONFIRMATION REQUIREMENTS

According to the Regulations of the Collegio Nuovo, the student's place is subject to annual confirmation based on merit requirements and conditions, including an average of at least 27/30 on university exams (with at least half of the credits passed by July and completed by the successive March 31st), compliance with the "Educational Agreement," and the "Hospitality Agreement." Students must sign the "**Educational Agreement**" with the College. This Agreement provides personalized training in addition to University studies and aligns with the objectives of the CCUM - Conference of University Colleges of Merit, which is accredited by the MUR - Italian Ministry of

University and Research (www.collegiuniversitari.it).

Upon completion of the program, students will receive the “**College Diploma**” issued jointly by the CCUM and the College, certifying the training course undertaken at the College. The relationship between Collegio Nuovo and each admitted student is also regulated by a special “**Hospitality Agreement**”.

STUDENTS ATTENDING THE *FILTER SEMESTER* AT THE UNIVERSITY OF PAVIA'S SCHOOL OF MEDICINE

Students attending the *filter semester* at the University of Pavia's Faculty of Medicine will be welcomed to the Collegio Nuovo to attend the University's program and reconfirmed upon admission to the University of Pavia. They will have access to an internal tutoring service designed to support them in preparing for the exams at the end of the *filter semester*. If they are not admitted, they may remain in the College for the entire academic year if they enroll in another *related* degree program at the University of Pavia. They will retain their place even if they enroll in courses outside of Biomedical Sciences and may be confirmed the following year if they meet the merit requirements of the College Regulations and pass an internal eligibility exam.

If these conditions are not met, students must leave the College by February 28th, 2026. Their contribution will be calculated in proportion to the period of their stay.

If vacancies remain after that date, the College reserves the right to proceed with the rolling of the 2025–26 competition list or, if necessary, to announce a new competition reserved for those admitted to the University of Pavia's Faculty of Medicine.

All data provided will be processed in accordance with the law on the processing of personal data.

Dear Interested Party,

In compliance with the provisions of art. 13 of EU Regulation 679/2016, "General Regulation on the protection of personal data" (RGPD) and national legislation Legislative Decree 196/2003 as amended by Legislative Decree 101/2018, as part of the procedure for participation in the competition for titles and examinations, the data you provide directly will be processed by the Foundation. In relation to this, therefore, we inform you that:

Data Controller

The Data Controller is the Sandra and Enea Mattei-Collegio Nuovo Foundation, in the person of the President and Legal Representative, with registered office in Via Abbiategrasso n. 404 - 27100 Pavia, Italy.

Interested

Students who are enrolled in the first year or are enrolled in a Bachelor or Master's degree course at the University of Pavia, father and mother of the student living together or not.

Purposes of data processing

The data provided by you are processed for the following purposes:

1. ascertaining and verifying the regulatory criteria for participation in the competition or for the renewal of the place in College and to benefit from benefits and advantages, services and activities offered in relation to the Call for applications and the Internal Regulations of the College,
2. management of the procedures related to the training and reporting activities of the Colleges of Merit, accredited by the MUR,
3. subsequent administrative management in case of admission,
4. exercise, in any venue, including judicial proceedings, of any right and any legal action provided for in Call in the interest and for the protection of the Foundation,
5. anonymously for internal statistical and historical purposes.

Should the Data Controller need to process the data provided for purposes other than those expressed above, before any further processing, he or she will provide you with all the information regarding this different purpose and any further relevant indications.

Data subject to processing

The personal data provided by the interested party are personal data and contact details, school career completed with qualification obtained and final mark of the High School Diploma, credits obtained, degree course chosen / taken, suitability for community life and sports activities, no criminal convictions, composition of the family with personal data and profession of father and mother, presence of sisters / brothers, any economic condition (such as ISEE) and / or benefit that you intend to enjoy (INPS, IUSS). In the context of the application and statements made, the Foundation is therefore also in possession of categories of so-called special data revealing racial or ethnic origin, religious beliefs, as well as data relating to the health or judicial information of the applicant and, for some of these, of the father and mother whose specific consent is requested in the documentation submitted both online and on paper.

Nature of the conferment of data and legal basis

The conferment of data and its processing are mandatory in relation to the purposes of points 1), 2), 3) and 4), any refusal would not allow the Owner to start the competition procedure and to comply with requirements arising from legal and regulatory provisions (eg. of emanation of the MUR) or to protect the legitimate interests of the Owner himself in case of litigation. Consent is, however, necessary for data of a particular nature given at the time of submission of the application for participation and/or attached documentation and must be expressed, in that forum, by the Interested Parties. Failure to provide it will result in the incompleteness of the documentation required by the Call for Applications and the Regulations and could compromise the execution of the procedure in whole or in part. The processing referred to in point 5), taking place on aggregated and anonymous data, necessary for internal statistical and historical purposes, does not allow the identification of the interested party, not even through the crossing of information and/or acquisition of additional information, since such data are deprived of all identification elements, are not, therefore, considered personal data and are not subject to the rules for the protection of personal data.

Processing methods

Personal data will be processed both in paper form and with the aid of electronic, computerised or telematic instruments, with logic strictly related to the purposes expressed above and, in any case, through organisational and IT security measures suitable to guarantee the confidentiality, integrity and availability of the data as well as the accuracy, updating and pertinence of the data according to the provisions of the regulations in force. Such data may be accessed and, therefore, come to knowledge, only and exclusively by persons expressly authorized and instructed by the Owner and / or external managers appointed, who may perform, according to the authorizations/nominations, operations of collection, recording, organization, storage, consultation, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and any other operation should it be necessary in compliance with the provisions of law. In particular, the data are not subject to dissemination or to any fully automated decision-making process, so in particular there is no profiling system.

Duration of treatment

For the purposes of the historical memory of the College, all data relating to the competitor, registered but not admitted or absent from the exams or who, despite having passed the competition, makes a different choice or becomes part of the collegiate



community, will be stored, both on computer and paper, in the Historical Archives of the Collegio Nuovo. All the documentation proving the regularity of the competition, such as admission rankings, tests taken, records with marks etc., signed by the commissioners, is, therefore, kept without time limit as proof of eligibility for the competition, in order to comply, as a body recognized and accredited by the MUR, the reports requested periodically in relation to eg. number of competitors, geographical origin, social conditions, etc. as well as for internal statistical and historical purposes.

At the closing of the call for applications, the ranking list is also published on the institutional website, indicating: position in the ranking list, name, score obtained. The ranking will remain available online for a period of 3 months.

Scope of communication and dissemination of data, recipients of data

In relation to the purposes expressed above, may become aware of your data authorized persons or external managers identified by the Owner in writing, such as:

- Employees/collaborators who, on the basis of roles and duties performed, have been authorized to process data, trained to do so within the limits of their skills and in accordance with the instructions given to them,
- Professionals or service companies for the management of computer systems (accounting, competition, canteen, personal data and Students / Guests career) and the Website,
- Members of the examination committee.

In addition, the data may be made accessible and communicated, for the stated and law purposes, to persons and/or third parties such as:

- MUR,
- Insurance companies,
- Qualified professionals for the protection and resolution of any legal problems and disputes,
- Judicial authorities (Guardia di Finanza, Police Forces, etc.),
- Universities and University Departments,
- CCUM (Conference of University Colleges of Merit).

The detailed list of persons/companies that process data on behalf of the Owner is available upon request at rettrice.collegionuovo@unipv.it/segreteria.collegionuovo@unipv.it. Access to such data shall be subject to an assessment of the legitimacy of the request. The holder shall not communicate and/or transfer the data to third countries outside the EU or to international organisations outside the EU. The data shall not be disseminated.

Rights of the interested parties

Pursuant to Articles 15 et seq. of Chapter III of EU Regulation 679/2016, the interested party may exercise the following rights:

- to obtain confirmation as to whether or not your personal data is being processed and, if so, to obtain access to such data and any other information related to and provided for in Article 15;
- to obtain, without undue delay, the rectification of inaccurate or incomplete data (Article 16), the cancellation - oblivion (Article 17), except for those contained in documents that must be kept by the Foundation and unless there is a prevailing legitimate reason to proceed with the processing, as well as the limitation of processing (Article 18). Any corrections or cancellations or limitations of the processing carried out will be communicated by the Data Controller to the recipients to whom the data are normally transmitted (art. 19);
- to receive in a structured format, in common use and readable by automatic device, personal data concerning you and transmit them to another data controller or obtain direct transmission of personal data from one data controller to another, if technically feasible - data portability (art. 20);
- to oppose, for reasons related to your particular situation, the processing of personal data concerning you (art. 21);
- to oppose a decision based solely on automated processing, including profiling (art. 22).

Revocation of consent and Complaint

If the processing is based on consent, the Data Subject has the right to revoke it at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation. The interested party also has the right to lodge a complaint with the Guarantor Authority for the Protection of Personal Data in accordance with art. 77 of the GDPR or to take appropriate legal action (art. 79 REG. EU 2016/679).

How to exercise your rights
